Original Degree Certificate is issued to all eligible candidates after it is conferred in Annual Convocation. But under the following circumstances it may be issued in advance prior to the Annual Convocation with the approval of the competent authority:

(A)To pursue higher study abroad,

OR

(B) To take up residence abroad,

OR

(C) Require the degree to join services in Government/PSO in India or abroad

OF

(D) Require the degree for registration in PCI / MCI or any other council

For issuance of Original Degree Certificate In Advance (Prior to Convocation), the following documents have to be submitted to the Office of the Controller of Examinations:

- 1. An Application for issue of Original Degree Certificate duly forwarded by Dean / Head of the Department
- 2. Self-attested copy of Transcript and Provisional Degree Certificate (PDC)
- 3. Self-attested copy of admission letter/appointment letter / any other relevant document as a proof for the requirement of original degree for the same.
- 4. Notarized Affidavit (on a Non-Judicial Stamp Paper of Rs. 10/- to support the requirement of degree prior to Annual Convocation duly attested by an 1st Class Magistrate/SDM. Format of the draft of text for Affidavit can be downloaded from SHUATS website.
